

Security Districts

A.D. 990

Located along all public streets and alleys within the area bounded by the centerline of Highland Avenue on the north, the centerline of that certain east/west alley south of 20th Street on the south, the centerline of Guthrie Street on the west, and the centerline of Arden Avenue on the east. There are 104 parcels in Zone 1 and 87 parcels in Zone 2. (Ward 7)

Sewer Line Maintenance Districts

A.D. 962

Located in the area generally located easterly of Pine Avenue and southerly of Belmont Avenue. There are 335 parcels assessed in this district. (Ward 5)

A.D. 963

Located in portions of Allen Street, north of Central Avenue. There are 28 parcels assessed in this district. (Ward 1)

A.D. 989

Located at the south side of Mill Street generally the street between Macy Street and the railroad right-ofway west of Macy Street. There are 208 parcels assessed in this district. (Ward 3)

A.D. 1024

Located in the Inland Center Drive and Riverwalk Drive area for the maintenance of a sewer lift station and landscaping. There are 63 parcels assessed in this district. (Ward 3)

Other Districts

A.D. 1018

Located within a portion of Tract 14448, Northpark Boulevard and Mountain Drive. District was formed to acquire improvements from developer. There are 98 parcels in this district (Ward 5)

A.D. 2006-1

This is a Special Tax District that assumed the revenues and responsibilities of this portion of CSA 38 L from the County of San Bernardino pursuant annexation of this area. This tax is for paramedic services. Located at Citrus Street on the north; Orchard Street on the south; Del Rosa Avenue on the east; and Golden Avenue on the west. There are 155 parcels (primarily residential and some commercial) within this district. (Ward 7)
