REGARDING THE PROPOSED 2023-2024
COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM ANNUAL ACTION PLAN

NOTICE IS HEREBY GIVEN that The City of San Bernardino (City) is an entitlement jurisdiction that receives Community Development Block Grant (CDBG), HOME Investment Partnerships, and Emergency Solutions Grant (ESG) funds directly from the U.S. Department of Housing and Urban Development (HUD). The City anticipates receiving approximately \$2,942,853 in CDBG, \$1,460,936 in HOME and \$273,557 in ESG funds.

As a condition to receiving these funds, each year the City must submit to HUD a One-Year Action Plan that explains how the City intends to invest these federal funds toward meeting the City's community development, affordable housing, and homeless prevention needs.

The City has prepared a draft of the Fiscal Year (FY) 2023-2024 Annual Action Plan as required by HUD. Citizens are encouraged to review the draft FY2023-2024 Annual Action Plan, copies will be available beginning Monday, April 3, 2023, through Monday, May 1, 2023, at the City of San Bernardino Community, Housing, and Economic Development Department, 201 N.
